FIG.1 FORWARD CURRENT DERATING CURVE







FIG. 2 TYPICAL REVERSE CHARACTERISTICS













#### FIG. 5 TYPICAL JUNCTION CAPACITANCE




#### FIG.6 REVERSE RECOVERY TIME CHARACTERISTIC AND TEST CIRCUIT DIAGRAM




